## **Brownfields Revolving Loan Funds Available**

AVCOG's Brownfields Cleanup Revolving Loan Fund, established with an \$800,000 grant from the U.S. Environmental Protection Agency (EPA), provides below market rate loans and/or subgrants to facilitate cleanup of contaminated properties (brownfields) within our service area.

The purpose of this program is to assist in the revitalization of these properties, promote jobs and create a cleaner environment for the communities within the AVCOG Region.

Loan funds are available to municipalities and other public entities, nonprofit agencies and organizations, and private property owners/developers who comply with the eligibility requirements of the EPA. Subgrants are only available to eligible municipalities and nonprofit owners of brownfield properties.

Phase I and Phase II Environmental Site Assessments and a plan for site remediation/cleanup must be complete to apply. Cleanup grants and loans require a 20 percent cost share from the applicant. Click here for more information about AVCOG's Brownfields Program.

# Lewiston-Auburn Passenger Rail Service Plan – Phase I Complete

The first phase of a study commissioned by the Northern New England Passenger Rail Authority (NNEPRA) and the Maine Department of Transportation (MaineDOT) to evaluate the potential expansion of passenger rail service to Lewiston-Auburn was recently completed. This phase resulted in the Transit Propensity Report designed to evaluate potential ridership demand for this service. The analysis was based on a variety of data sources, including existing traffic volumes, origin-destination data, census data and Journey to Work data, as well as current and historical Downeaster ridership information.

Two public open houses were held early last spring and an online survey was used to gather public input. Based on the data, comments, local input, and analysis, the study estimates a low of 600 to a high of 800 daily trips in 2025, for a transit–style service (frequent round–trip daily). The next phase of the plan is to evaluate operating service scenarios, rail corridor and station/connection locations, and infrastructure. The final report is expected to be complete in the spring of 2019.
